This Limited Warranty is only available to the original owner of the appliance at the original installation location. It is not transferable. This appliance must be installed by a licensed and qualified contractor who is trained on IBC's products. Improper installation of the appliance (including the failure to install the appliance in accordance with applicable building codes/ordinances, regulations and standards, good plumbing and electrical trade practices, or the Installation and Operating Manual) will invalidate warranty coverage. IBC warrants this appliance, and its component parts, to be free from defects in materials and manufacture, under normal use and service, during the Applicable Limited Warranty Periods and subject to the Limited Warranty Exclusions set out below. In its sole discretion, IBC will repair or replace the defective appliance, or defective component part(s), in accordance with the terms of this Limited Warranty, if it fails in normal use and service during the Applicable Limited Warranty Periods. The replacement appliance must be manufactured by IBC. The replacement component part(s) must be IBC authorized component part(s). The replacement appliance or component part(s) will be warrantied only for the unexpired portion of the original appliance's Applicable Limited Warranty Periods.

EFFECTIVE DATE

The Effective Date of this Limited Warranty coverage (or the beginning of the Applicable Limited Warranty Periods) is the date of installation of the appliance, if properly documented. If you are not able to provide documentary proof of the date of installation, the Effective Date is the date of manufacture of the appliance plus ninety (90) days.

APPLICABLE LIMITED WARRANTY PERIODS

Definitions:

Residential - Single family dwelling only

Controlled recirculation – A domestic hot water recirculation line using a circulator controlled by a thermostat/aquastat (set to 90% of the domestic hot water set point of the tankless water heater), and/or timer so that the circulator operates intermittently.

Uncontrolled recirculation - A domestic hot water recirculation line using a circulator that is operating 24 hours a day.

Space heating – Any type of space heating system other than for direct domestic hot water without a storage tank. Example: Radiant floor heating, ducted heating system, fin tube baseboard, snowmelt, etc.

Commercial – Commercial use is allowed if the unit is regularly maintained and the heat exchanger is cleaned at least once a year, or more often if the unit is experiencing heavy use. Note: If the appliance is serving only one residential appliance in a multi-family building, then the appliance shall be considered used for residential use.

Labor and other costs incurred for diagnosing, repairing, removing, installing, shipping, servicing, maintaining, or other handling of either defective parts or replacement parts are not included in this Limited Warranty.

This Limited Warranty will NOT cover:

- Service trips to your business to teach you how to install, use, or maintain this water heater or to bring the water heater installation into compliance with applicable building codes/ ordinances, regulations and standards, or manufacture installation requirements as described in the Installation and Operating Manual.
- This tankless water heater if it is installed for use in: a spa or pool heating; a recreational vehicle; and a boat or any other watercraft, b) including houseboats.
- Appliances installed in any circulating system in which the temperature of the incoming water to the water heater is in excess of 140°F. c)
- This tankless water heater if it is installed in any installation supplying radiant heat, such as in floor, baseboard, radiators, snow melt, or d) closed loop systems, using glycol or non-potable water.
- Damages, malfunctions or failures resulting from improper installation of the appliance, including installation by a person who is not a e) licensed or qualified contractor, and/or trained on IBC products and failure to install the appliance in accordance with applicable building codes/ordinances, regulations and standards, good plumbing and electrical trade practices or the Installation and Operating Manual.
